TERMS OF PARTICIPATION

1. VENDOR shall pay to Cat Tales, Inc. a non-refundable fee of forty Dollars (\$40.00) or 10% in total sale (food vendors) in exchange for the right to conduct its normal business activities within its 10' x 10' booth space (or truck size) at the Fast and Furriest Car Show (“SHOW”). The fee and one signed copy of this Agreement must be received by Cat Tales, Inc. by August 1, 2018.
2. All proceeds earned by VENDOR at the SHOW shall remain the property of VENDOR.

3. VENDOR will provide its own table, tent (**NOTE:** We do not have tents to lend out) and any other equipment necessary for VENDOR to properly conduct its activities at the SHOW.
4. VENDOR agrees that it will not offer bottled water, soda, or baked goods for sale at the SHOW. (Cat Tales, Inc. will have bottled water, soda, and baked goods available for sale at the SHOW.) VENDOR also agrees to list in the space provided below, merchandise, including food and beverage items (if applicable), it will offer for sale that day.
5. VENDOR agrees to be ready to conduct business when the SHOW opens at 10:00 AM, and to remain ready to conduct business until 3 PM, when the SHOW closes. VENDOR agrees that it will not begin to break down its display until 3 PM.
6. VENDOR agrees that its representatives shall not drive on the lawn or in undesignated areas, and that the rented booth space shall be COMPLETELY cleaned of trash, leaving the booth space in the same clean condition it was in prior to the SHOW.
7. VENDOR agrees to release and discharge Cat Tales, Inc., Knights of Valhalla Car Club, Garage Guys Car Club, Middletown High School and all volunteers from any liability for damage to property belonging to VENDOR, for any injuries received by VENDOR, its agents and employees, or for any costs incurred by VENDOR relating to its appearance at the SHOW.
8. If VENDOR cannot fulfill its obligation to be present at the SHOW, VENDOR will make every effort to give seven (7) days advance notice of its cancellation to Cat Tales, Inc.
9. VENDOR and its representatives have read and agree to abide by the **GUIDELINES** in the enclosed packet of information.
10. VENDOR agrees that it shall abide by the above policies and procedures and that any misrepresentations to Cat Tales, Inc., Knights of Valhalla Car Club, and Garage Guys Car Club or any violation of the above policies and procedures will result in VENDOR not being invited back to future Cat Tales, Inc. events.
